The aim of this paper is to design an adaptive fuzzy control law $\mathbf{u}(t)$, without the knowledge of the control direction, such that the system output $y(t)$ tracks a given desired trajectory $\mathbf{y}_d(t) = \left[y_{d1}(t), \ldots, y_{dp}(t) \right]^T$ as closely as possible while all signals in the closed-loop system remain bounded.

In order to control uncertain nonlinear system (1), the following assumptions are required.

Assumption 1. Each desired trajectory $y_{di}(t)$, $i = 1, ..., p$, and its time derivatives up to order r_i are continuous and bounded.

Assumption 2. The control gain matrix $G(x)$ is nonsingular, and all its leading principal minors are nonzero and their signs are unknown.

Remark 1. Assumption 2 means that the control gain matrix may be non-symmetric and indefinite. Moreover, if some principal minors of the matrix $G(x)$ are zero, an interchange of rows or columns may be needed before proceeding to controller design.

Since the matrix $G(x)$ is nonsingular with nonzero leading principal minors, the following lemma (Boulkroune *et al*., 2010; Tao, 2013) will be used in the controller design.

Lemma 1. Consider a real matrix $G(x)$ with nonzero leading principal minors. Then it can be decomposed as:

function; i.e. \mathbf{D}^* is a diagonal matrix with diagonal entries $d_i^* = +1$ or -1, $\mathbf{T}(\mathbf{x})$ is a unity upper triangular matrix

Remark 2. The diagonal matrix \boldsymbol{D}^* contains information on the control direction, i.e. the sign of the control gain matrix $G(x)$. It is worth to note that the knowledge of the control direction \boldsymbol{D}^* is crucial for constructing a stable controller parameter adaptation law. However, in this paper, the control direction \boldsymbol{D}^* is assumed unknown and it will be estimated online (its diagonal entries) by an appropriate adaptation law.

Now, we define the tracking errors as follows

From (5), $s_i(t) = 0$ is a linear differential equation whose solution implies that $e_i(t)$ converges to zero with a time constant $(r_i - 1)/\lambda_i$. In addition, the time derivatives of $e_i(t)$ up to order r_i –1 also converge to zero (Slotine and Li, 1991). Thus, the control objective becomes the design of a controller to enforce $s_i(t)$ to converge to zero, $i = 1, \ldots, p$.

The time derivatives of the filtered errors (5) are

If the nonlinear functions $f(x)$ and $G(x)$ are known, to accomplish the control objective, we can apply the following nonlinear control law (Labiod and Guerra, 2007)

where, $\mathbf{K} = diag \begin{bmatrix} k_1, ..., k_p \end{bmatrix}$, $\mathbf{K}_0 = diag \begin{bmatrix} k_0, ..., k_{0p} \end{bmatrix}$, with $k_i > 0$ and $k_{0i} > 0$, for $i = 1, ..., p$, ε_0 is a small positive constant, and $tanh(\cdot)$ is the hyperbolic tangent function.

Actually, when we choose the control input as $u = u^*$, equation (8) becomes

From (11) one can conclude that $s_i(t) \to 0$ as $t \to \infty$ and, accordingly, $e_i(t)$ and all its time derivatives up to order $r_i - 1$ converge asymptotically to zero (Slotine and Li, 1991).

However, in this paper, the nonlinear function $f(x)$ is assumed unknown and the control gain matrix $G(x)$ is also assumed unknown with unknown sign. Consequently, the ideal nonlinear control law (9) cannot be used. In such a case, we propose a design method relying on the estimation of the sign of the control gain matrix (the diagonal entries of the matrix \boldsymbol{D}^*) and on the approximation of the entire unknown ideal control law (9) by using adaptive fuzzy systems.

3. DESCRIPTION OF THE USED FUZZY SYSTEMS

In this paper, we approximate the unknown continuous functions by using the zero-order Takagi-Sugeno fuzzy system. This fuzzy logic system performs a mapping from an input vector $z = [z_1, ..., z_m]^T \in \Omega_z \subset \mathbb{R}^m$ to a scalar output $y_f \in \mathbb{R}$, where $\Omega_z = \Omega_z \times \cdots \times \Omega_z$ and $\Omega_z \subset \mathbb{R}$. Let us define M_i fuzzy sets F_i^j , $j = 1, ..., M_i$, for each input variable z_i , then the Takagi-Sugeno fuzzy logic system will be characterized by a set of if-then fuzzy rules of the following form (Labiod and Guerra, 2007; Wang, 1994)

where $G_i^k \in \left\{F_i^1, \ldots, F_i^{M_i}\right\}, i = 1, \ldots, n, y_f^k$ is the crisp output of the *k -*th rule, and *N* is the number of rules.

By considering the singleton fuzzifier strategy and the product inference engine, the output of the fuzzy system can be expressed as follows (Wang, 1994)

The output (13) can be written in the following compact form (Wang, 1994)

where $\theta = \left[y_j^1, \dots, y_j^N \right]^T$ is a vector grouping all consequent parameters, and $w(z) = [w_1(z), ..., w_N(z)]^T$ is a set of fuzzy basis functions defined as

The fuzzy system (13) is assumed to be well-defined so that $\sum_{j=1}^{N} \mu_j(z) \neq 0$ for all $z \in \Omega_z$.

It has been proved in Wang (1994) that fuzzy systems in the form of (14) with Gaussian membership functions can approximate continuous functions over a compact set. The approximation accuracy is related to the number of fuzzy rules considered.

4. ADAPTIVE FUZZY CONTROL DESIGN

In order to design the adaptive control law, each entry of the ideal control law (9) will be approximated by a fuzzy system in the form of (14) as the following

where $z = \left[x^T, s^T\right]^T$, $w_i(z)$ is a fuzzy basis function vector which is specified by the designer, θ_i^* is an unknown ideal parameter vector, and $\varepsilon_i(z)$ is the fuzzy approximation error which is assumed bounded.

Let us define the following vectors and matrices

After the specification of the control law, the next step should be the design of the controller parameter adaptation law to meet the control objective. However, because the control direction (i.e. the sign of the control gain matrix $G(x)$ defined

by the signs of the diagonal entries of the matrix \boldsymbol{D}^*) is unknown, to get a stable adaptation, the parameter adaptation law should be combined with an online control direction estimator.

Adding and subtracting $G(x)u^*$ to the right-hand side of (8) leads to the following error dynamics

Using (9) , (19) becomes

$$
\dot{s} = -K s - K_0 \tanh\left(s/\varepsilon_0\right) + G(x)e_u \tag{20}
$$

where $e_u = u^* - u$.

By using Lemma 1, the matrix $G(x)$ can be expressed as

$$
G(x) = GS(x) D* T(x) = GS(x) D* + \Delta G(x) \qquad (21)
$$

where $\Delta G(x) = G_s(x) D^* (T(x) - I_p)$ with I_p the identity matrix of size *p* .

Substituting (21) into (20) yields

$$
\dot{s} = -K s - K_0 \tanh\left(s/\varepsilon_0\right) + G_s \left(x\right) D^* e_u + \Delta G(x) e_u \qquad (22)
$$

From (17) and (18), one can write $\boldsymbol{D}^* \boldsymbol{e}_u$ as

$$
\boldsymbol{D}^* \boldsymbol{e}_u = \boldsymbol{D}^* \left(\boldsymbol{w}^T \left(z \right) \tilde{\theta} + \varepsilon \left(z \right) \right) \tag{23}
$$

Using the fact that $\mathbf{D}^* = \mathbf{D}^* - \mathbf{D} + \mathbf{D} = \tilde{\mathbf{D}} + \mathbf{D}$, where $\tilde{\mathbf{D}} = \mathbf{D}^* - \mathbf{D}$ and $\mathbf{D}^* = \text{diag} \begin{bmatrix} d_1, d_2, ..., d_n \end{bmatrix}$ is the estimate of the unknown control direction $\boldsymbol{D}^* = \text{diag} \left[d_1^*, d_2^*, \dots, d_n^* \right]$, (23) can be further written as

$$
\boldsymbol{D}^* \boldsymbol{e}_u = -\tilde{\boldsymbol{D}} \boldsymbol{u} + \boldsymbol{D} \boldsymbol{w}^T \left(z \right) \tilde{\theta} + \tilde{\boldsymbol{D}} \boldsymbol{w}^T \left(z \right) \theta^* + \boldsymbol{D}^* \varepsilon \left(z \right) (24)
$$

By defining the following lumped disturbance term $\delta = \tilde{\boldsymbol{D}} \boldsymbol{w}^T(z) \boldsymbol{\theta}^* + \boldsymbol{D}^* \boldsymbol{\varepsilon}(z)$, it follows that

$$
\boldsymbol{D}^* \boldsymbol{e}_u = -\tilde{\boldsymbol{D}} \boldsymbol{u} + \boldsymbol{D} \boldsymbol{w}^T \left(z \right) \tilde{\theta} + \delta \tag{25}
$$

Let use define $\boldsymbol{d}^* = \left[d_1^*, d_2^*, \ldots, d_n^*\right]^T$, $\boldsymbol{d} = \left[d_1, d_2, \ldots, d_n\right]^T$ and $\tilde{d} = d^* - d$, so, we have $\tilde{D}^* = \text{diag}[d^*]$, $D = \text{diag}[d]$ $\tilde{\boldsymbol{D}} = \text{diag}\left[\tilde{\boldsymbol{d}}\right]$.

In order to obtain a stable adaptation without the knowledge of the control direction \boldsymbol{D}^* and inspired by our previous works (Labiod and Guerra, 2007, 2016, 2017), the following cost function $J = \frac{1}{2} (\boldsymbol{D}^* \boldsymbol{e}_u)^T \boldsymbol{G}_s (\boldsymbol{x}) (\boldsymbol{D}^* \boldsymbol{e}_u)$ $J = \frac{1}{2} (\boldsymbol{D}^* \boldsymbol{e}_u)^T \boldsymbol{G}_s (\boldsymbol{x}) (\boldsymbol{D}^* \boldsymbol{e}_u)$ can be used to derive

the following robust parameter adaptation laws

$$
\dot{\theta} = \eta_1 \ \mathbf{w}(\mathbf{z}) \mathbf{D}(\dot{\mathbf{s}} + \mathbf{K} \mathbf{s} + \mathbf{K}_0 \tanh(\mathbf{s}/\varepsilon_0)) - \eta_1 \sigma_1 \theta \quad (26)
$$

$$
\dot{\boldsymbol{d}} = -\eta_2 \operatorname{diag}[\boldsymbol{u}](\dot{\boldsymbol{s}} + \boldsymbol{K} \boldsymbol{s} + \boldsymbol{K}_0 \tanh(\boldsymbol{s}/\varepsilon_0)) - \eta_2 \sigma_2 \boldsymbol{d} \hspace{0.2cm} (27)
$$

where η_1 and η_2 are two strictly positive design constants, σ_1 and σ_2 are two small positive design constants.

Consider the following Lyapunov function candidate

$$
V = \frac{1}{2} s^T s + \frac{1}{2\eta_1} \tilde{\theta}^T \tilde{\theta} + \frac{1}{2\eta_2} \tilde{\boldsymbol{d}}^T \tilde{\boldsymbol{d}} \tag{28}
$$

The time derivative of *V* is

$$
\dot{V} = \mathbf{s}^T \dot{\mathbf{s}} - \frac{1}{\eta_1} \tilde{\theta}^T \dot{\theta} - \frac{1}{\eta_2} \tilde{\mathbf{d}}^T \dot{\mathbf{d}} \tag{29}
$$

Substituting (20), (26) and (27) into (29), and using the equality $\dot{s} + K s + K_0 \tanh(s/\varepsilon_0) = G(x) e_u$, one gets

\dot{V} = -\mathbf{s}^T \mathbf{K} \, \mathbf{s} - \mathbf{s}^T \mathbf{K}_0 \, \tanh\left(\mathbf{s}/\varepsilon_0\right) + \mathbf{s}^T \mathbf{G}\left(\mathbf{x}\right) \mathbf{e}_u
$$
\n
$$
-\left(-\tilde{\mathbf{D}} \, \mathbf{u} + \mathbf{D} \, \mathbf{w}^T \left(\mathbf{z}\right) \tilde{\boldsymbol{\theta}}\right)^T \mathbf{G}\left(\mathbf{x}\right) \mathbf{e}_u + \sigma_1 \tilde{\boldsymbol{\theta}}^T \boldsymbol{\theta} + \sigma_2 \tilde{\boldsymbol{d}}^T \boldsymbol{d} \tag{30}
$$

By using (25) one obtains

$$
\dot{V} = -\mathbf{s}^T \mathbf{K} \, \mathbf{s} - \mathbf{s}^T \mathbf{K}_0 \tanh\left(\mathbf{s}/\varepsilon_0\right) - \mathbf{e}_u^T \mathbf{G}_s\left(\mathbf{x}\right) \mathbf{e}_u + \mathbf{s}^T \mathbf{G}\left(\mathbf{x}\right) \mathbf{e}_u
$$
\n
$$
+ \mathbf{e}_u^T \mathbf{D}^* \Delta \mathbf{G}^T\left(\mathbf{x}\right) \mathbf{e}_u + \delta^T \mathbf{G}\left(\mathbf{x}\right) \mathbf{e}_u + \sigma_1 \tilde{\theta}^T \theta + \sigma_2 \tilde{\mathbf{d}}^T \mathbf{d} \tag{31}
$$

By completion of squares, the following equalities hold

$$
\sigma_1 \tilde{\theta}^T \theta = \sigma_1 \tilde{\theta}^T \left(-\tilde{\theta} + \theta^* \right) = -\frac{\sigma_1}{2} \left\| \tilde{\theta} \right\|^2 - \frac{\sigma_1}{2} \left\| \theta \right\|^2 + \frac{\sigma_1}{2} \left\| \theta^* \right\|^2 \tag{32}
$$

$$
\sigma_1 \tilde{\theta}^T \mathbf{d} = \sigma_2 \tilde{\theta}^T \left(\tilde{\mathbf{d}} + \mathbf{d}^* \right) = -\frac{\sigma_2}{2} \left\| \tilde{\mathbf{d}} \right\|^2 - \frac{\sigma_2}{2} \left\| \mathbf{d} \right\|^2 + \frac{\sigma_2}{2} \left\| \mathbf{d}^* \right\|^2 \tag{33}
$$

\sigma_2 \tilde{d}^T d = \sigma_2 \tilde{d}^T \left(-\tilde{d} + d^* \right) = -\frac{\sigma_2}{2} \left\| \tilde{d} \right\|^2 - \frac{\sigma_2}{2} \left\| d \right\|^2 + \frac{\sigma_2}{2} \left\| d^* \right\|^2 \tag{33}
$$

Now, by considering the fact that the σ -modification parameter adaptive laws (26) and (27) ensure the uniform boundedness of the adaptive parameters θ and \boldsymbol{d} , we can assume that the following inequality holds

+ $e_{u}^{T} \mathbf{D}^{*} \Delta G^{T}(x) e_{u} - \frac{\sigma_{1}}{2} ||\theta||^{2} + \frac{\sigma_{1}}{2} ||\theta^{*}||^{2} - \frac{\sigma_{2}}{2} ||d||^{2} \le$ (34)
 $\kappa_{1} s^{T} K s + \kappa_{2} e_{u}^{T} G_{s}(x) e_{u} + \frac{\kappa_{3}}{2} ||\tilde{\theta}||^{2} + \frac{\kappa_{4}}{2} ||\tilde{d}||^{2} + \overline{\kappa}(t)$

where κ_1 , κ_2 , κ_3 , κ_4 are positive constants and $\bar{\kappa}(t)$ a positive bounded function.

By using the above equations (31)-(34), the time derivative of *V* can be upper bounded as

$$
\dot{V} \leq -\left(1 - \kappa_1\right) s^T K s - \left(1 - \kappa_2\right) e_u^T G_s(x) e_u
$$
\n

-\frac{1}{2} \left(\sigma_1 - \kappa_3\right) \left\|\tilde{\theta}\right\|^2 - \frac{1}{2} \left(\sigma_2 - \kappa_4\right) \left\|\tilde{d}\right\|^2 + \overline{\kappa}

If the following inequalities are satisfied: $\kappa_1 < 1$, $\kappa_2 < 1$, $\kappa_3 < \sigma_1$ and $\kappa_4 < \sigma_2$, (35) can be rewritten as

$$
\dot{V} \le -\alpha V + c \tag{36}
$$

where $\alpha = \min\left(2(1-\kappa_1)\lambda_{\min}(\boldsymbol{K}), \eta_1(\sigma_1-\kappa_3), \eta_2(\sigma_2-\kappa_4)\right),$ $c = \sup_{t} \left(-(1 - \kappa_2) e_u^T G_s(x) e_u + \overline{\kappa}(t) \right).$

We are now ready to prove the following theorem.

Theorem 1. For uncertain MIMO nonlinear system (1), under Assumptions 1 and 2, the control law (18) with parameter adaptation laws (26) and (27) guarantees the boundedness of all the signals in the closed-loop system and the asymptotic convergence of the tracking error to a small neighborhood of the origin.

Proof. By integrating (36) over $[0,t]$, one can obtain the following inequality

$$
0 \le V(t) \le \frac{c}{\alpha} + \left(V(0) - \frac{c}{\alpha}\right)e^{-\alpha t} \tag{37}
$$

From inequality (37), one can conclude that all signals of the closed-loop system are uniformly bounded and that the filtered tracking error $s(t)$ is uniformly ultimately bounded with

respect to the set: $\left\{ s \in \mathbb{R}^p : \left\| s(t) \right\| \leq \sqrt{\frac{2c}{\alpha}} \right\}$ $\begin{bmatrix} 1 & \cdots & 1 \\ 0 & \cdots & 0 \end{bmatrix}$ $\mathbf{s} \in \mathbb{R}^p : ||\mathbf{s}(t)|| \leq \sqrt{2\pi}$. This in turn implies

that each tracking error $e_i(t)$ and its first $(r_i - 1)$ derivatives converge to residual sets defined as: $|e^{(j)}(t)| \leq 2^{j} \lambda^{j-n+1} \sqrt{\frac{2c}{\alpha}}$,

$$
j = 0, \ldots, r_i - 1, i = 1, \ldots, p
$$
.

Remark 3. In this paper, in order to improve the performance of the adaptive fuzzy controller, the parameter adaptation law is obtain by the minimization of a cost function that quantifies the error between \boldsymbol{u}^* and \boldsymbol{u} (Labiod and Guerra, 2007).

5. SIMULATION RESULTS

In this section, in order to validate the effectiveness of the presented adaptive fuzzy controller, we apply it to a two-link robotic manipulator moving in a vertical plane. The dynamic model of the two-link robotic manipulator is given by (Ordonez and Passino, 1999; Slotine and Li, 1991)

\ddot{\boldsymbol{q}} = \boldsymbol{M}^{-1}(\boldsymbol{q})\big(\boldsymbol{D}^*\boldsymbol{u} - \big(\boldsymbol{C}\big(\boldsymbol{q},\dot{\boldsymbol{q}}\big)\dot{\boldsymbol{q}} + \boldsymbol{G}\big(\boldsymbol{q}\big) + \boldsymbol{F}\big(\dot{\boldsymbol{q}}\big)\big)\big) \qquad (38)
$$

where $q = [q_1, q_2]^T$ are the joint angles, $u = [u_1, u_2]^T$ are the joint inputs, and

$$
M = \begin{bmatrix} M_{11} & M_{12} \\ M_{21} & M_{22} \end{bmatrix}, C(q, \dot{q}) = \begin{bmatrix} -h\dot{q}_2 & -h(\dot{q}_1 + \dot{q}_2) \\ h\dot{q}_1 & 0 \end{bmatrix},
$$

The following parameter values are used in this paper: $I_1 = 0.2 \text{ kg} \text{m}^2$, $I_2 = 0.2 \text{ kg} \text{m}^2$, $m_1 = 1.0 \text{ kg}$, $m_2 = 1.0 \text{ kg}$, $\ell_1 = 1.0 \text{ m}, \qquad \ell_2 = 1.0 \text{ m}, \ell_{c1} = 0.5 \text{ m}, \qquad \ell_{c2} = 0.5 \text{ m},$ $g = 9.8 \text{ m/s}^2$. Let $y = q$, $x = [q_1, \dot{q}_1, q_2, \dot{q}_2]^T$, and $f(x) = -M^{-1}(C(q, \dot{q})\dot{q} + G(q) + F(\dot{q})), G(x) = M^{-1}D^*$

Then, the robot manipulator dynamics given by (38) can be written as

$$
\ddot{y} = f(x) + G(x)u, \qquad (39)
$$

Equation (39) is in the input-output form given by (2) and the matrix $G(x) = M^{-1}D^*$ is nonsingular. Note that the matrix

 \boldsymbol{D}^* is a diagonal matrix with $+1$ or -1 on the diagonal and it is introduced to change the control direction.

The control objective is to force the robot manipulator outputs $y_1 = q_1$ and $y_2 = q_2$ to track the following desired trajectories $q_{1d} = \sin(t)$ and $q_{2d} = \cos(t)$, respectively.

Within this simulation, two fuzzy systems in the form of (14) are used to generate the control signals u_1 and u_2 . The input vector of each fuzzy system is defined as $z = [e_1(t), \dot{e}_1(t), e_2(t), \dot{e}_2(t)]^T$, and for each input variable z $, i = 1, \ldots, 4$, we define three Gaussian membership functions centered at -1.25 , 0, 1.25 with a variance equal to 0.6. The robot system initial conditions are $\mathbf{x}(0) = [0.25, 0, 0.5, 0]^T$, the initial values of the estimated parameters $\theta(0)$ are set equal to zero, and the initial values of the estimated control direction is $d(0) = [-0.5, -0.5]^T$. The used design parameters are chosen as follows: $\lambda_1 = 2$, $\lambda_2 = 2$, $K = diag[5, 5]$, $K_0 = diag[5,5], \eta_1 = 2, \eta_2 = 2, \varepsilon_0 = 0.01, \sigma_1 = 0.001, \text{ and}$ $\sigma_{2} = 0.001$.

Simulation results for the case $\boldsymbol{D}^* = \text{diag}[-1,1]$ are shown in Figs. 1–3. Fig. 1 shows actual and desired joint positions of links 1 and 2. Fig. 2 shows joint control torque inputs. Fig. 3 shows the estimated control directions d_1 and d_2 . We can see that actual trajectories converge to the desired ones, and that the control direction is correctly identified.

Simulation results for the case $\boldsymbol{D}^* = \text{diag}[+1, -1]$ are shown in Figs. 4–6. Fig. 4 shows actual and desired joint positions of links 1 and 2. Fig. 5 shows joint control torque inputs. Fig. 6 shows the estimated control directions d_1 and d_2 . We can see that we obtain similar control tracking performance.

6. CONCLUSIONS

For a class of uncertain MIMO nonlinear systems with indefinite control gain matrix and unknown control direction, this paper has proposed a direct adaptive controller by using fuzzy systems. The fuzzy systems are used to approximate an unknown ideal nonlinear control law that ensures the control objective. Under the assumption that the unknown control gain matrix is indefinite, by using a matrix decomposition technique, the unknown control direction and the adjustable parameters of the fuzzy controller are adjusted online by a suitable parameter adaptive law that minimizes the error between the ideal control law and the fuzzy controller. Using the Lyapunov direct approach, all the closed-loop signals have been shown to be uniformly bounded. The effectiveness of the proposed adaptive control scheme has been demonstrated by simulation studies.
